STATEMENT OF THE CASE

This is a contested case proceeding under Iowa Code chapters 85 and 17A. The expedited procedure of rule 876 IAC 4.48 is invoked by claimant, Allen Werner. The attorneys for the respective parties informed the undersigned deputy workers' compensation commissioner they had reached an agreement with respect to future treatment for claimant.

- 1) Claimant will be referred to the Mayo Clinic for assistance in tapering off opioid medication and for other pain management therapies;
 - 2) Defendants will provide ongoing psychiatric care; and
- 3) Defendants will provide reasonable travel and living expenses for claimant while he is attending the Mayo Clinic.

The agreement between the parties is approved and ordered.
